HEALTH AND SAFETY AT WORK ACT DECONTAMINATION CERTIFICATE

Any product which is to be returned to Airbox Sampling Products or serviced on site must be cleaned and decontaminated in the appropriate manner and placed in the decontamination bag supplied. This certificate, duly completed, must be either sent in advance (fixed to the **outer** packing containing the product), or handed to the service engineer.

NOTE: Packages will not be opened nor servicing commenced until the Company or service engineer have received a satisfactory certificate. Should returned goods be considered a hazard by the Company, they will be returned immediately to the customer at their expense or can be cleaned by Airbox service team. **Any pumps requiring decontamination by Airbox service team will be charged at £10 per pump.**
